CONSIDERING WE ARE AN ORGANIZATION THAT ADVOCATES GET OUT THE VOTE FOR POLITICAL ELECTIONS, IT IS DISMAYING TO READ OUR VOTER TURNOUT STATS FOR THIS IMPORTANT ORGANIZATIONAL ELECTION ARE SO VERY LOW.

THERE WERE GLITCHES THAT OCCURRED WITH SOME ADDRESSES WITH '<u>COMCAST.NET</u>' MAIL SERVICE, AND MEMBERS WHO UNSUBSCRIBED AND EMAILS BUMPED BACK. TERESA SAGEN AND I WORKED TO RESOLVE THOSE EMAIL ADDRESS ISSUES.

#### Artist Statement

This piece shows that the light is still there although it is being weighed down and overshadowed. The crescent represents the shadow my disability casts over my life with the 15 rings along the top edge representing the symptoms I struggle through and endure every day. The light below the crescent is barely holding on by the five rings that attach it to the crescent. It is only those five rings that represent the things that are keeping my light from falling. The carnelian in the center of the light represents the courage and strength I need to keep hanging on.

#### Artist Statement

The name of my painting is "Colorful Wonder". The painting depicts me as a child in a bright yellow shirt and rainbow headband set against a colorful blue background. I played off the bright colors in the original photo to inspire the style of my painting. I wanted to create a whimsical rendition of the original photo to visually connect the whimsicality of childhood, leading to my decision to use watercolor. To create my painting, I first sketched the girl, and then I painted in the lightest shades of color, leaving the lightest highlights white. Next, I built up darker and darker colors until the contrast between colors created a realistic picture. The most evident element of art in my painting is color. I used bright colors to emphasize the youthful whimsy style I was aiming to achieve. Contrast is the most evident principle of art. The contrast helps create depth and establishes a sense of realism.

## It's Time To Vote






